## WATER EFFICIENT TECHNOLOGY (WET) PROGRAM

### GENERAL INFORMATION

JEA offers commercial rebates for a variety of water-saving measures including low-flow pre-rinse spray valves, ENERGY STAR® dishwashers, high-efficiency toilets and urinals, faucet aerators, custom measures, and more.

Pre-approval before the purchase or installation of eligible water upgrades is required. All measures are available to JEA Commercial Water customers and not eligible for residential use.

Rebates for additional energy and water efficiency measures may be available. ### WATER EFFICIENT TECHNOLOGY (WET) PROGRAM

#### ELIGIBILITY REQUIREMENTS

1. You do not need to engage a Trade Ally to purchase/install water-saving measures.
2. An inspection may be required prior to installing the water measures. Inspections are randomly selected and are typically conducted for larger projects.
3. Used or refurbished equipment is not eligible. All equipment must be new.
4. Rebates for high-efficiency toilets are only available for existing toilets 1.6 gpf or higher. Rebates for high and ultra high-efficiency urinals are only available for existing urinals 1.5 gpf or higher.
5. Custom measures require a narrative description of existing/baseline conditions and proposed steps to implement the measure(s). Calculations are also required to substantiate estimated GPD water use reduction in an Excel file.
6. Business Rebates are capped at \$100,000 per project (location) per year, not to exceed 50% of the total project cost.
7. Service locations using reclaimed water, or water from a well, lake, pond, etc. for irrigation are not eligible for irrigation and landscaping measure rebate consideration.

#### APPLICATION INSTRUCTIONS

2. Choose the water-saving measures you wish to install. A pre-inspection may be required, so ensure your chosen measures are not removed until you receive the JEA pre-approval letter.
3. Submit your application via the [Online Application Portal](#). For assistance, contact our Customer Service Center at [JEAbusiness@icf.com](mailto:JEAbusiness@icf.com) or 1-844-604-4393.
4. Once you receive the pre-approval letter, purchase and install your pre-approved water-saving measures.
5. Contact us once all the measures are fully installed and submit final invoices through the online application portal. A post-inspection may be required.
6. Upon JEA's final review and approval, you will receive your rebate check within 4-6 weeks.
